

**DECISION OF THE GOVERNMENT OF THE RUSSIAN FEDERATION
NO. 50 OF JANUARY 26, 2007 ON AMENDING AND RECOGNIZING AS
HAVING LOST FORCE CERTAIN ACTS OF THE GOVERNMENT OF
THE RUSSIAN FEDERATION ON THE ISSUES OF THE STATE DUTY
(with the Amendments and Additions of June 23, 2007, February 16,
April 7, 16, 2008)**

The Government of the Russian Federation hereby resolves:

1. To approve the hereto enclosed Amendments, which shall be introduced into the acts of the Government of the Russian Federation on the issues of the state duty.

2. To recognize as having lost force the acts of the Government of the Russian Federation in accordance with the enclosed List.

**Amendments to Be Introduced into the Acts of the Government of the
Russian Federation on the Issues of the State Duty (approved by
Decision of the Government of the Russian Federation No. 50 of
January 26, 2007) (with the Amendments and Additions of June 23,
2007, February 16, April 7, 16, 2008)**

1. Item 1 of the Rules for the Formalization and Issue of Hire Certificates for Cinema and Video Films, approved by Decision of the Council of Ministers - the Government of the Russian Federation No. 396 of April 28, 1993 on the Registration of Cinema and Video Films and on the Regulation of Their Public Demonstration (Sobraniye Aktov Prezidenta i Pravitelstva Rossiiskoy Federatsii, No. 18, 1993, Item 1607; Sobraniye Zakonodatelstva Rossiiskoy Federatsii, No. 48, 2000, Item 4689), shall be extended by a paragraph of the following content:

"- the document, confirming the payment of the state duty for the issue of a hire certificate for cinema and video films."

2. In Item 3 of Decision of the Council of Ministers - the Government of the Russian Federation No. 793 of August 12, 1993 on the Approval of the Regulations on the Duties for Patenting Inventions, Useful Models and Industrial Samples, for the Registration of Trade Marks, Servicing Marks, Designations of the Places of Commodity Origin and for Granting the Right to the Use of Designations of the Places of Commodity Origin, and of the Regulations on Registration Fees for the Official Registration of the Software for Computers, of the Data Bases and the Integral Microscheme Topologies (Sobraniye Aktov Prezidenta i Pravitelstva Rossiiskoy Federatsii, No. 34, 1993, Item 3182), the words, "and of the registration

fees, than that stipulated in the enclosed provisions", shall be replaced by the words, ", than that stipulated in the enclosed Regulations".

a) Item 4 shall be rendered in the following edition:

"4. For obtaining a licence, to the Commission shall be submitted the following documents:

"- an application in accordance with the form supplied in Appendix 1;

"- the Rules of the commodity exchange;

"- the constituent agreement, or an application for the registration, or another document, if such is envisaged at the creation of the commodity exchange;

"- the document, confirming the fact of making an entry on the legal entity into the Uniform State Register of Legal Entities;

"- the Rules for the Exchange Trade;

"- the document, confirming the contribution into the authorized capital of the commodity exchange of no less than 50 per cent of the declared sum of money;

"- the document, certifying the right to the use of the corresponding premises for conducting auctions;

"- the list of the founders and the distribution among them of partner shares (in percentages) in the authorized capital of the commodity exchange, with an indication for natural persons of their posts at all places of employment;

"- the document, confirming the payment of the state duty for the consideration by the licencing body of an application for being granted a licence.

"The documents, enclosed to the application for drawing a licence, shall be submitted as filed and confirmed by the seal of the exchange, or by a notary.";

b) in Item 10 the words, "the transfer of a single-time fee", shall be replaced by the words, "the payment of the state duty for being granted a licence".

In the Regulations on Licencing the Activity of Enterprises, Institutions and Organizations Aimed at the Performance of Works Connected with the Use of Information Comprising the State Secret, with the Creation of Means for Protecting Information, as Well as with an Implementation of and (or) with Rendering Services Involved in Protecting

the State Secret, approved by Decision of the Government of the Russian Federation No. 333 of April 15, 1995 on Licencing the Activity of Enterprises, Institutions and Organizations for the Performance of Works, Connected with the Use of Information Comprising the State Secret, with the Creation of Means for Protecting Information, as Well as with an Implementation of Measures and (or) with Rendering Services Involved in Protecting the State Secret (Sobraniye Zakonodatelstva Rossiiskoy Federatsii, No. 17, 1995, Item 1540):

a) in Subitem f) of Item 5, the words, "the payment for the consideration of an application", shall be replaced by the words, "the payment of the state duty for the consideration by the licencing body of an application for being granted a licence";

b) in the fourteenth paragraph of Item 8, the words, "its payment, whose size is equal to the cost of a licence form", shall be replaced by the words, "the payment of the state duty for being granted a licence".

a) in the seventh paragraph of Item 3, the words, "the payment for the consideration of an application", shall be replaced by the words, "the payment of the state duty for the consideration by the licencing body of an application for being granted a licence";

b) in the sixth paragraph of Item 4, the words, "the payment for the consideration of an application", shall be replaced by the words, "the payment of the state duty for the consideration by the licencing body of an application for being granted a licence";

c) Item 7 shall be rendered in the following edition:

"7. For the consideration of an application for being granted a licence by the licencing body and for the issue of a licence, a state duty shall be paid in the size and in the order, established in the Legislation of the Russian Federation on taxes and fees.";

d) in Item 13 the words, "its payment", shall be replaced by the words, "the payment of the state duty for the issue of a licence".

b) in Item 25, the words, "the payment for being granted a licence", shall be replaced by the words, "the payment of the state duty for the issue of a licence";

c) Item 37 shall be edited as follows:

"37. For the consideration of an application for being granted a licence by the licencing body and for the issue of a licence, the state duty shall be paid in the amount and in the order, established in the Legislation of the Russian Federation on taxes and fees."
