On the drafts in the sphere of technical regulation of the Customs union

The Customs Union Commission decided:

1. In order to implement the Agreement on common principles and rules of technical regulation in the Republic of Belarus, Kazakhstan and the Russian Federation - to approve:
 - Action Plan for implementation of the Agreement on common principles and rules of technical regulation in the Republic of Belarus, Kazakhstan and the Russian Federation (attached);
 - Regulations on the development, adoption, amendment and the abolition of the technical regulations of the Customs Union (attached);
 - Schedule of priority technical regulations of the Customs Union (attached).
2. Approve Working Plan of the Coordinating Committee for technical regulation, the application of sanitary, veterinary and phytosanitary measures for 2010-2011.
3. Paragraph 1 of this Decision shall enter into force upon adoption of the Agreement on common principles and rules of technical regulation in the Republic of Belarus, Kazakhstan and the Russian Federation.
